

Twenty-Fifth Meeting, Portland, USA, 19-20 June 2003

# Summary Record of the 25<sup>th</sup> Energy Working Group Meeting

The twenty-fifth meeting of the APEC Energy Working Group (EWG) was held in Portland, USA on 19-20 June 2003. Australia and the United States co-chaired the meeting.

Delegates from Australia; Chile; the People's Republic of China; Hong Kong, China; Japan; Republic of Korea; Mexico; New Zealand; the Philippines; Russia; Singapore; Chinese Taipei; Thailand; and the United States participated in the meeting. Representatives from the EWG and APEC Secretariats also attended. The Asia Pacific Energy Research Centre (APERC), the Expert Groups on Energy Data and Analysis (EGEDA), Minerals & Energy Exploration and Development (GEMEED), Clean Fossil Energy (EGCFE), New and Renewable Energy Technologies (EGNRET) and Energy Efficiency and Conservation (EGEE&C), and the Energy Business Network (EBN) were represented at the meeting.

# 1. Opening address by the Co-Chairs of the Meeting and the Adoption of the Agenda.

The EWG Lead Shepherd, Mr John Ryan, opened the meeting and invited his Co-Chair, Mr Robert Price, Director European and Asian Affairs, Department of Energy, USA, to make the opening address.

Mr Price warmly welcomed delegates to EWG25 and to Portland. He emphasised that the United States is committed to the EWG and achieving the APEC objectives of trade liberalisation and economic growth within the region and highlighted some of the EWG's achievements.

Mr John Ryan thanked Mr Price, on behalf of delegates attending EWG25, for his address and for the excellent meeting facilities provided by the United States. Mr Ryan also thanked Viet Nam for their offer to host EWG25 and expressed regret that the meeting could not take place as planned. The Chair welcomed the EBN Chair to the meeting. Mr Ryan commented that the EWG is recognised as an important multi-economy group by a range of observers. He then outlined the business for the meeting.

The agenda for the meeting was adopted.

# 2. Report from the Ninth Meeting of the Energy Working Group Business Network (EBN9)

The Chair of the EWG Business Network, Ms Lic. Angélica Fuentes Téllez, presented a report from EBN9, held on 17 June 2003 in Portland, USA.

In her report, Ms Fuentes thanked the EWG for inviting the EBN to participate fully in the EWG meeting and also thanked the United States EBN Member and the PECC Energy Forum for hosting EBN9. Ms Fuentes outlined the EBN proposal to hold public-private workshops to share knowledge and experiences on a range of issues of relevance to the EWG. She advised that workshops could be organised by government or business, and that they would complement the IFAT mechanism.

Ms Fuentes added that EBN Members recognised the importance of access to finance for investment in energy infrastructure, suggesting that the first public-private workshop address this issue and could be held in conjunction with EBN10. She reported that the EBN also recognises the importance of sustainable development and that activities to address this issue should be practical and project-based.

Ms Fuentes advised that the next EBN would be hosted in Hong Kong, China at a date that will allow EBN Members to also attend EWG26 in the Republic of Korea.

Members <u>noted</u> the report provided by Ms Fuentes and the *Summary of Decisions Taken* that was tabled at EWG25.

#### Action Arising/Next Steps

- Future EBN meetings will be held back-to-back with EWG meetings.
- EBN10 be held in Hong Kong, China at a time that allows EBN Members to attend EWG26 in the Republic of Korea.

## 3. Proposals Arising from the Ninth Meeting of the Energy Working Group Business Network (EBN9)

The EWG Secretariat provided an overview of the proposals arising from the EBN for consideration by the EWG.

#### Proposal to have Government-private sector workshops

EWG Members <u>noted</u> the EBN suggestion of holding workshops and its objective of facilitating the sharing of knowledge and experiences and that the workshops could be hosted by a government or business. Members <u>agreed</u> that given the importance of investment in energy infrastructure in the APEC region, the EBN should investigate the feasibility of holding a financial workshop in conjunction with EBN10.

# The role of the business community in sustainable development

Members <u>noted</u> the EBN suggestion that the EWG's approach to sustainable development be practical and project based, and that public-private partnerships will be essential to its implementation.

# Project proposals being considered by the EWG for funding in 2004

Members <u>noted</u> the EBN's support for the proposed project 'Carbon Dioxide Capture and Geological Sequestration Potential of the APEC Region', <u>noting</u> that it would build upon the current project that is being overseen by Canada and complement initiatives being undertaken by other fora.

Members also <u>noted</u> the EBN's support for the proposed project 'Best Practice in Cross-Border Interconnection of Gas Pipelines in APEC Member Economies', and <u>agreed</u> with their suggestion to extend its scope to include LNG.

# **Action Arising/Next Steps**

- EBN Members will investigate holding a workshop on financing of infrastructure to be held in conjunction with EBN10.
- The project proposal, 'Best Practice in Cross-Border Interconnection of Gas Pipelines in APEC Member Economies', be <u>extended</u> in scope to include LNG.

# 4. APEC and EWG Secretariat Reports

Mr Tong Xianguo, Director (Program) APEC Secretariat and Mr Wayne Calder, Manager, EWG Secretariat, presented their respective Reports to Members.

Mr Tong outlined APEC priorities for 2003 and reported on the outcomes of SOM II and the meeting of the APEC Counter Terrorism Task Force (CTTF), including the endorsement of the CTTF action plan, the APEC response to SARS, reporting requirements of APEC for SOM, and the decision at SOM II to request that the EWG develop an implementation plan, with timeframes, for the APEC Energy Security Initiative, noting that this is a deliverable to the APEC Economic Leader's Meeting. He also advised of the deadline for submitting APEC project proposals for 2004.

Mr Calder emphasised the importance of maintaining an up to date contact list of EWG Members, requesting that the Secretariat be notified of and changes to contact details for EWG delegates. He also indicated that the EWG Secretariat can advise Members of the requirements for APEC projects, and that the EWG web site is being regularly updated and is an excellent source of information on EWG initiatives, activities and projects.

The EWG Lead Shepherd thanked Vicki Brown and the EWG Secretariat for the excellent work that Australia undertakes in support of the EWG.

Members noted the Secretariat Reports.

# Action Arising/Next Steps

- EWG Secretariat to <u>provide</u> the list of prioritised projects to the APEC Secretariat by 30 June 2003, to enable them to be considered by the BMC.
- EWG Secretariat to <u>provide</u> the APEC Secretariat with a report on the EWG work plan for 2003, and its activities over the past year.

# 5. Implementation of Type 2 Initiative: Energy for Sustainable Development

EWG Members <u>noted</u> and <u>discussed</u> the report on implementation of the Type 2 Initiative, including the progress of activities being undertaken under the Initiative and proposals to further progress its implementation.

Members <u>noted</u> the proposals to incorporate sustainable development principles in EWG projects, increase emphasis on its practical implementation and human elements, strengthen its relationship with the Energy Security Initiative, and consider its relationship with other sustainable development initiatives.

Members <u>agreed</u> that sustainable development principles should be introduced in the consideration of EWG projects.

Members also <u>agreed</u> that the Type 2 Initiative should be closely linked with the Energy Security Initiative, citing a number of examples where projects address sustainable development and energy security. Members also <u>discussed</u> the importance of access to finance in achieving sustainable development objectives, and again considered the EBN proposal to conduct a financial workshop, agreeing that it would support the directive of APEC Energy Ministers to engage business participation in EWG activities.

Members <u>noted</u> that business involvement includes State run companies and that these companies should be encouraged to participate in EBN activities. APERC highlighted its expertise in this field and offered to provide input into the workshop based on research it has undertaken. EGNRET and EGEE&C also advised that they are undertaking projects addressing access to finance.

# **Action Arising/Next Step**

- EWG Secretariat to further <u>examine</u> how sustainable development principles could be incorporated into the EWG project proposal process, and <u>report</u> to EWG26.
- Australia and the United States to assist the EBN in <u>assessing</u> the feasibility of holding a financial workshop in conjunction with EBN10.

# 6. Implementation of APEC Energy Security Initiative

Members <u>noted</u> the progress of the Energy Security Initiative, including that SOM II has directed the EWG to develop an implementation plan with appropriate timeframes, to be reported to SOM III. Given the short period time before SOM III, it

was agreed that the EWG Secretariat develop an implementation plan for the Energy Security Initiative and circulate to Members for comment and approval out of session.

# Action Arising/Next Step

• EWG Secretariat <u>develop</u> an implementation plan for the Energy Security Initiative, with appropriate timeframes, and <u>distribute</u> to EWG Members for comment and approval out of session and prior to SOM III.

Members then <u>discussed</u> each of the initiatives under the Energy Security Initiative.

# 6.1 Report from the Oil Supply Emergency Response Workshop

Members <u>noted</u> the positive feedback from workshop participants and the 'Report on Workshop Outcomes' prepared by the EWG Secretariat, including its three recommendations:

- 1. That at each EWG meeting beginning with EWG26, one member economy make a presentation to the EWG on their energy emergency response arrangements. This would be voluntary and operate on a rotational basis;
- 2. That the EWG hold workshops to address specific issues regarding the development and implementation of energy emergency response plans; and
- 3. That Implementation Assistance Facilitation Teams (IFAT) be used as a mechanism for assisting member economies to develop and implement energy emergency response plans.

Members <u>endorsed</u> each recommendation, with the Republic of Korea offering to make a presentation at EWG26.

Members also <u>discussed</u> the International Energy Forum (IEF), <u>agreeing</u> that the EWG Lead Shepherd should approach the IEF to encourage increased interaction between the fora.

# **Action Arising/Next Step**

- Republic of Korea to <u>present</u> on their energy emergency response arrangements at EWG26.
- The EWG Lead Shepherd to <u>write</u> to the Executive Director of the IEF in relation to increasing interaction.

# 6.2 Progress of the Monthly Oil Data Initiative

Members <u>noted</u> the report by Ms Karen Schneider, Vice-Chair of EGEDA, on the progress of the Joint Oil Data Initiative (JODI), which has been in permanent operation since late 2002. Members <u>noted</u> that timeliness and quality of data is essential to the success of the Initiative and although EWG member economies are improving in this regard, there is room for further improvement with EGEDA offering to assist these efforts.

Members <u>agreed</u> that JODI is a valuable initiative and every effort should be made by economies to improve their data provision to EGEDA.

# Action Arising/Next Step

• EWG Members to continue to <u>support</u> JODI and <u>provide</u> EGEDA with quality and timely data.

# 6.3 Real-time Emergency Information Sharing

Members <u>considered</u> the proposal developed by Japan, in consultation with Korea and the Philippines, for a real-time emergency information sharing system. Members <u>noted</u> the various functions of the system, which is intended to provide a more systematic and responsive mechanism for communication and data provision to improve crisis management during emergencies.

Members <u>agreed</u> that the EWG would have the capacity to undertake such an activity and that the system could be implemented once issues regarding the confidentially of data and duplication with existing initiatives are addressed. Members also <u>agreed</u> that, as a first step, an appropriate contact point could be identified within each member economy.

Japan thanked Members for their comments and agreed to <u>finalise</u> the proposal and seek EWG <u>endorsement</u> out of session.

# **Action Arising/Next Step**

- Japan to <u>finalise</u> the proposal and submit to EWG Members for <u>approval</u> out of session.
- EWG Members to <u>advise</u> Japan of an appropriate contact point within their economies.

# 6.4 Implementation of other measures.

Members <u>noted</u> progress towards the implementation of other measures under the Initiative, agreeing that efforts to diversify the energy mix is crucial to long term energy security. Members <u>discussed</u> several projects and initiatives, particularly for natural gas and hydrogen.

Members <u>agreed</u> that the EWG should continue efforts to promote energy diversity within member economies, for example through cross-border gas interconnection, including LNG, and a study into natural gas supply and demand. Members <u>noted</u> that these activities should recognise and build upon other work that has been undertaken, for example, for the World Gas Congress.

As a part of the longer-term objectives of the APEC Energy Security Initiative, the EWG <u>discussed</u> a proposal to collaborate on hydrogen and fuel cell development to spur the growth of hydrogen. Appropriate collaboration would be carried out as part of the APEC 21<sup>st</sup> Century Renewable Energy Development Initiative (under the APEC Expert Group on New and Renewable Energy) and would be coordinated with the activities of the APEC Expert Group on Clean Fossil Energy.

Members <u>noted</u> that at SOM II the United States advocated that the EWG should work towards the development of technology that can promote the usage of hydrogen. To facilitate further discussion of hydrogen in the SOM process, the United States distributed a concept paper on hydrogen collaboration for EWG representatives to take back to their SOM representative. Members <u>noted</u> that further information would be provided to progress hydrogen cooperation in the EWG. The EWG will look for further instructions on promoting hydrogen cooperation from the SOM.

# Actions Arising/Next step

• The United States, with the assistance of the EWG Secretariat, to <u>provide</u> EWG Members, out of session, with further information regarding its approach to long term energy security.

# 7. Energy Literacy Initiative

Japan presented a report on Energy Literacy Initiative.

Members <u>noted</u> that the Initiative's first meeting took place in Bangkok on 27-28 March 2003, with the next meeting planned for late 2003. Members <u>agreed</u> that the Initiative would need to accommodate language and cultural differences between member economies, and Members were <u>encouraged</u> to support the Initiative.

# **Action Arising/Next Step**

• Nil.

# 8. Engaging Financial Institutions in EWG Activities

Members <u>considered</u> the scoping paper provided by the EWG Secretariat outlining options for the EWG to engage financial institutions. Members <u>agreed</u> that the option for conducting a workshop with financial institutions was the most appropriate at this time.

Members had extended <u>discussions</u> regarding the challenges in attracting investment in the energy sector. Members <u>agreed</u> that this is an issue of enormous significance that it should be included on the agenda of the 6<sup>th</sup> Energy Minister's Meeting to be held in 2004.

# Action Arising/Next Step

• That the issue of engaging financial institutions for investment in energy infrastructure be <u>included</u> on the agenda of the 6<sup>th</sup> Energy Minister's Meeting.

# 9. Pledge and Review

EWG Members <u>noted</u> the contributions to the voluntary Pledge and Review Program, and the Annual Reports submitted by Australia; Chile; Hong Kong, China; Japan; Mexico; Philippines; Singapore and Thailand. Annual Reports were tabled at EWG25 by Chinese Taipei and the Republic of Korea.

Members <u>noted</u> the *Fourth Report of the Energy Working Group on the Pledges and Review Program* prepared by the EWG Secretariat and member economies that had not yet submitted their Pledge and Review contributions were <u>encouraged</u> to do so as soon as possible.

Members <u>discussed</u> ways to reinvigorate the Pledge and Review Program and noted that while it is an important Initiative, its original focus appears to have moved and that it would be beneficial if the information shared was of more interest and relevance to other Members. The EWG Secretariat suggested that it could assist by asking targeted questions for the report and undertaking some analysis of the information submitted.

# Action Arising/Next Steps

- APEC Member economies that have not done so are <u>encouraged to submit</u> their Pledge and Review contribution to the EWG Secretariat for circulation to EWG Members.
- The United States, Japan and the EWG Secretariat <u>develop</u> a scoping paper on ways to reinvigorate the program, for consideration at EWG26.

# 10. Policy Dialogue: Impediments to Energy Exploration and Development

EWG Members held a <u>policy dialogue</u> on the topic *Impediments to Energy Exploration and Development.* As previously agreed, no records of discussion were taken under this item. Members <u>noted</u> that the policy dialogue was enhanced through the attendance of the EBN.

Members <u>noted</u> the request to further discuss this issue within the EWG and <u>agreed</u> that for EWG26 the policy dialogue topic would be 'The Role of Energy Services in the APEC Region'.

# Action Arising/Next Steps

• That the policy dialogue topic for EWG26 is 'The Role of Energy Services in the APEC Region'.

# 11. Framework for discussion of nuclear energy within the EWG

Members <u>noted</u> that there was broad acceptance of the importance of this issue and welcomed dialogue on this issue. Members <u>thanked</u> the Republic of Korea and Mexico for the paper on the framework for discussion of nuclear energy within the EWG. Members, in recognition of the sensitivities surrounding nuclear energy, <u>agreed</u> that they would provide comments out of session to finalise the framework paper on the way forward. The Republic of Korea thanked Members for their comments.

The Republic of Korea made a presentation on the Training Program for nuclear energy that it will host in the first half of 2004. Members <u>supported</u> the implementation of the training program to build capacity within interested member economies and <u>thanked</u> the Republic of Korea for its presentation.

## **Action Arising/Next Steps**

- Members to <u>provide comment</u> to the EWG Secretariat on the proposed framework for the discussion of nuclear energy within the EWG.
- Members to <u>encourage</u> participation by interested economies in the Training Program for nuclear energy.

# 12. Report from the APERC President and discussion of EWG priorities.

Members <u>noted</u> the APERC President's report, which highlighted APERC's four research activities for 2002-03 and four proposed research activities for 2003-04.

Members <u>congratulated</u> APERC for their report and the work they are undertaking. Members <u>indicated</u> that the proposed research projects for 2003-04 appear consistent with EWG priorities and <u>stressed</u> that the EWG should continue to be the prime body guiding the APERC work program.

Members were advised that Japan is currently reviewing its contributions to APERC. Members noted the preliminary results of the questionnaire on APERC activities, including that the EWG highly values the APEC Supply and Demand Outlook and database on energy statistics and that, under certain circumstances, some economies would be willing to provide APERC with funding support. Members <u>discussed</u> the oversight arrangements for APERC and the relationship between APERC and EGEDA. Members <u>agreed</u> that the EWG Secretariat would report on the nature of the relationship at EWG26.

Members <u>emphasised</u> the importance of APERC's data collection, demand-supply outlook and analysis to energy policy development within APEC economies. Members also <u>thanked</u> Japan for the resources they had provided to APERC and suggested that member economies express their support for APERC directly to Japan.

Japan thanked Members for their positive comments and stated that funding or 'inkind' support would be greatly appreciated, adding that there are no restrictions regarding how APERC can be funded. Members were also advised that Japan will be preparing, for EWG consideration, a draft medium-term strategic plan for the support of APERC.

# Action Arising/Next Steps

- EWG Members to have <u>forwarded</u> the completed APERC questionnaire to METI, and to <u>advise</u> Japan whether they would be able to make a financial or 'in-kind' contribution to APERC, by 31 July 2003.
- Japan to <u>report</u> its draft medium-term strategic plan for the support of APERC at EWG26.
- EWG Secretariat to <u>report</u> to EWG26 on the nature of the APERC-EGEDA relationship.

# 13. Report of the Meeting of the Chairs of the EWG Expert Groups

The EWG Secretariat presented a Report to Members on the outcome of the meeting of the EWG Expert Groups' Chairs held in Portland, USA on 18 June 2003. Members <u>noted</u> that Expert Groups had undertaken a range of activities since EWG25 and submitted several project proposals for EWG consideration. Members were advised of the Chairs' strong interest in the financial workshop proposed by the EBN and that Chairs had agreed to undertake measures to improve communication between Expert Groups and with the EWG. Members also <u>noted</u> that the next Expert Group Chairs' meeting will be held in conjunction with EWG26. Members were informed that EBN Members also attended the Expert Group Chairs meeting and expressed their support for the work of the Expert Groups.

An EWG member <u>reported</u> that the meeting was particularly productive, with a high level of interaction between Chairs and a strong commitment for Expert Groups to collaborate with each other and with APERC on areas of mutual interest.

Members were provided with a Summary Record of the meeting and the Progress Reports prepared by each of the Expert Groups.

# Action Arising/Next Steps

• Nil.

# 14. EWG Project Proposals for 2004

Members <u>noted</u> that 31 project proposals had been submitted for the EWG consideration. Of these, 14 sought funds from the APEC Operational Account, 15 sought funds from the TILF Special Account, and 2 were self-funded.

Members <u>endorsed</u> all project proposals. Members <u>amended</u> the project "Best Practise in Cross-Border Interconnection of Gas Pipelines in APEC Member Economies", to include consideration of LNG.

Members <u>ranked</u> the projects in the following order in accordance with the agreed EWG method. Members agreed to submit all projects to the BMC.

# **15.** Sponsorship of APEC Activities

EWG Members <u>considered</u> the draft Sponsorship Agreement and 'How to Guide' prepared by the EWG Secretariat, noting that the documents are non-mandatory and designed to complement the APEC Sponsorship Policy Guidelines recently approved by APEC SOM and provide the EWG with practical assistance when seeking sponsorship.

Members made initial comments and <u>agreed</u> to provide the Secretariat with further feedback out-of-session.

# Action Arising/Next Steps

- EWG Members to provide the EWG Secretariat with feedback on the draft sponsorship documents by 31 July 2003.

# 16. Statements on Notable Energy Developments since EWG24

The Chair thanked Australia; Chile; Hong Kong, China; Mexico; the Philippines; Singapore, Thailand and the United States for providing their Statements on Notable Energy Developments. At the meeting, Statements were tabled from the Republic of Korea, Japan, New Zealand, and Chinese Taipei. EWG Members who tabled their Statements at the meeting were encouraged to provide an electronic copy to the EWG Secretariat by 4 July 2003 for circulation to Members.

# 17.1 Earthquake Response Cooperation Initiative

Chinese Taipei reported on the various activities being undertaken under the Initiative, including its series of annual workshops. Members <u>noted</u> that the next Workshop will be held in Taipei on 3 September 2003, with member economies encouraged to attend and propose speakers. Members also <u>noted</u> that the cooperative mechanism developed from the 2002 Workshop is being drafted and will be reported to EWG26.

EWG Members <u>noted</u> the Progress Report and <u>thanked</u> Chinese Taipei for their efforts to address what is a very important Initiative for member economies.

- Chinese Taipei to <u>report</u> on the Initiative's cooperative mechanism to EWG26.
- Members to <u>suggest</u> speakers for the annual Workshop, to be held on 3 September 2003.

# **17.2 21<sup>st</sup> Century Renewable Energy Development Initiative**

EWG Members <u>noted</u> the Progress Report provided by the Chair of the Expert Group on New Renewable Energy Technology (EGNRET) and the detailed report on the 21<sup>st</sup> Century Initiative progress tabled at EWG25. EWG Members <u>noted</u> that the 21<sup>st</sup> Century Initiative was mentioned by Ministers at EMM5 and by APEC Leaders at their last meeting. An EBN Member provided a demonstration of the APEC-CPI, an Internet based information system.

The Chair of EGNRET thanked EWG Members and the EWG Secretariat for their assistance in getting the 21<sup>st</sup> Century Renewable project on to the agenda for EMM5 and the APEC Leader's Meeting.

Members <u>were encouraged</u> to identify suitable people within their economies to attend the workshop in Singapore on 23 August 2003.

# 17.5 Measuring the Impacts of New Economy Technologies on the Energy Sector in APEC Member Economies

Members <u>noted</u> that the scope of the project proposal was recently amended to now examine the impact of new technologies. Members <u>noted</u> that the amendment has been approved by the APEC Budget and Management Committee and that a revised Request for Tender has been developed and will be tendered in the near future.

# 17.6 Energy Standards and Labelling Cooperation Initiative

Members <u>noted</u> the progress of the Initiative, including the finalisation of the three-year work plan and the standards and labelling information and tools available through the APEC-ESIS website. Members were <u>advised</u> that for the Standards Notification Procedure, several member economies had not yet provided official contacts. Members were <u>encouraged</u> to facilitate this.

#### Action Arising/Next Steps

 Members to <u>notify</u> the Chair of the EGEE&C of their economy's contact for the Standards Notification Procedure.

# 18. Other Business

EWG Members <u>noted</u> the request by the IEA to attend EWG26 and present to Members on a range of issues relating to renewable energy. Members supported the proposal but requested that it be limited to making a presentation on the issues identified.

Members were advised that the EWG will not be presenting at the Sustainability Energy Expo in Singapore in November 2002, and <u>noted</u> that several issues on the agenda will be relevant to the Type 2 Initiative and that presentations will be made by four APEC economies.

# Action Arising/Next Steps

• That the IEA be <u>invited</u> to attend EWG26, with participation limited to making a short presentation to Members.

# **19.** Review of the Lead Shepherd Position

Members <u>discussed</u> the arrangements regarding the positions of Lead Shepherd/ Chair, and Deputy Lead Shepherd/Co-Chair and the EWG Secretariat, <u>noting</u> that the role of Deputy /Co-Chair is traditionally undertaken by the host of each meeting.

All economies personally <u>thanked</u> Australia for their excellent work as Lead Shepherd and Secretariat over a number of years and <u>expressed</u> a desire that they continue in this role.

Australia thanked Members for their comments and <u>agreed</u> to continue as EWG Lead Shepherd and Secretariat.

# 20. Date for Next Energy Working Group Meeting.

Members <u>noted</u> the offer by the Republic of Korea to host EWG26 in Seoul from 2-5 December 2003.

Members <u>thanked</u> the Republic of Korea for their offer but raised some concerns regarding the proposed date and sought clarification of the proposed meetings. Members <u>agreed</u> that the EWG Secretariat work with the Republic of Korea to identify a suitable date and meeting arrangements, and advise Members out of session.

Members also thanked China for their offer to host EWG27 in the first half of 2004.

Members <u>thanked</u> and <u>accepted</u> the Philippines for their very kind offer to host the 6<sup>th</sup> Energy Minister's Meeting in June 2004.

#### Action Arising/Next Steps

 The EWG Secretariat work with the Republic of Korea to <u>confirm</u> arrangements for EWG26 and <u>advise</u> EWG members out of session.

# 21. Document Access

EWG Members <u>agreed</u> that the Summary Record and other final documents from this meeting could be released to the public immediately after the meeting.
