



Authorized Economic Operator

- AEO arrangement is a major standard under the Customs-to-Business Pillar of the WCO SAFE Framework of Standards (FoS) to Secure and Facilitate Global Trade.
- AEO is a party involved in the international movement of goods in whatever function that has been approved by or on behalf of a national Customs administration as complying with WCO or equivalent supply chain security standards.







- In June 2005, the WCO adopted the SAFE FoS to Secure and Facilitate Global Trade.
- In the APEC forum, the Ministers responsible for Trade agreed in principle in 2005 to implement the APEC Framework for Secure Trade





Global Situation of AEO Programme Implementation (Cont'd)


- As at August 2010, <u>162</u> of 176 WCO members have undertaken to implement the SAFE FoS.
- 20 of 21 APEC economies have expressed their intention to implement the SAFE FoS.
- 14 economies have implemented their own AEO programmes (Some have also started their AEO mutual recognition arrangements.)







- Statement of the Chair
 - Support the establishment of AEO programme in each economy, and promote mutual recognition arrangements.
 - Pursue the steady implementation of the AEO Action Plan, including the development of the AEO Best Practices.
 - Continue developing communication networks to facilitate the resumption of trade in the event of a major disruption to the global supply chain.





- Launched on 23 June 2010
- Implementation plan
 - To run for about 12 months
 - To involve about 10 forerunners
 - To start with Shippers (i.e. Importers/Exporters)



Reasons for Implementing AEO Programme

- Adapts to the new environment and links up with the global AEO development
 - Aims:
 - to maintain HKC's competitive edge as an international trading centre and regional logistics hub;
 - to enhance HKC's trading partners' confidence in the security of HKC's exports; and
 - to facilitate clearance of goods (originated from or transshipped through HKC) by overseas Customs administrations.





Reasons for Implementing AEO Programme (Cont'd)



- Provides a mechanism for Customs and business to develop supply chain best practices.
 - Aims:
 - HK Customs To achieve a dual aim of enhancing Customs enforcement and facilitating legitimate trade
 - AEOs To reap benefits, including faster Customs clearance through reduced examination and predictable Customs procedures



Reasons for Implementing AEO Programme (Cont'd)



- Shows our readiness to cooperate with the international community to secure the international supply chain.
 - Considerations:
 - HKC is a member of the WCO and APEC;
 - HKC's principal trading partners have implemented their AEO programmes on different scales







Reasons for launching an AEO Pilot

- The <u>AEO Implementation Guidance</u> of the <u>WCO SAFE Package</u> advises Customs administrations to carry out a pilot before formally implementing an AEO programme.
- A majority of the economies which have already implemented their AEO programmes had launched pilot projects.



Reasons for launching an AEO Pilot (Cont'd)

- HKC has its unique trading environment, which is characterized by, among others, :
 - a significant proportion of SMEs;
 - a small number of manufacturing industries; and
 - sophisticated transportation and communication networks.
- The WCO Framework Standards may <u>not</u> be <u>all</u> applicable to HKC's situation.





Reasons for launching an AEO Pilot (Cont'd)

- Provides a platform to collect views from the local industries
 - Industries may have better knowledge of AEO programme implementation and a better grasp of their security status in the international supply chain (through joining AEO programmes in other economies).
 - Information collected in the pilot would help refine <u>AEO</u> <u>application, validation and assessment</u> process, and identify areas for further enhancement.





Principles of HK AEO Programme

- Fits the unique local trading environment;
- Caters for SMEs;
- Does not require legislative amendments;
- Does not necessitate any changes to the existing business operation or customs clearance procedures;
- Complies with the WCO standards; and
- Makes reference to the AEO best practices of other Customs administrations and other international standards, such as the ISO.








Core Features of HK AEO Pilot

- Open and Voluntary
 - All local companies, regardless of their size and nature of business, can choose to join.
 - HK Customs starts with several companies and expands the scope progressively.





- High Flexibility
 - Considers operators' security profile on an individual basis and allows flexibility in assessing whether they could meet the criteria for obtaining AEO status.
 - Advises the operators of their compliance level and the ways on how they could meet the unfulfilled standards.
 - Allows mandatory and value-added requirements based on operators' business models.





Core Features of HK AEO Pilot (Cont'd)

- Two types of AEO Status
 - Tier 1 AEOs
 - Target: Small Companies
 - 3 General Criteria + 7 Security & Safety Criteria
 - Tier 2 AEOs
 - Target: Large Companies
 - 3 General Criteria + 9 Security & Safety Criteria



Core Features of HK AEO Pilot (Cont'd)

- 3 General Criteria:
 - Tier 1 and Tier 2 AEOs
 - (1) Customs Compliance;
 - (2) Maintenance of Commercial Records; and
 - (3) Financial Soundness







Security & Safety Criteria:

For Tier 1 and Tier 2 AEOs

- (1) Premises Security and Access Control;
- (2) Personnel Security;
- (3) Cargo Security;
- (4) Conveyance Security;
- (5) Business Partner Security;
- (6) Security Education and Training; and
- (7) Information Exchange, Access and Confidentiality
 For Tier 2 AEOs only
- (8) Crisis Management and Incident Recovery; and
- (9) Measurement, Analysis and Improvement


Benefits for AEOs in HKC

- Less physical Customs examination when compared with other economic operators;
- Priority treatment of consignments if selected for customs inspection;
- Choice of place of controls (for containerized sea cargo only);





- Other indirect benefits like reducing theft and losses, improved customer confidence and improved security and communication with partners in the supply chain;
- Recognized as a secure and safe business partner "Kite Mark";
- Further trade facilitation deriving from mutual recognition; and
- Special priority treatment of consignments for Tier 2 AEOs at times of disruption to border operations.







Way Forward

- To conduct review after AEO Pilot;
- To devise a timetable of implementing the AEO programme on full scale; and
- To maintain close liaison with other Customs administrations on their AEO implementation and exchange views on <u>mutual recognition</u>.
