Mr. Eric Holloway is the Director for APEC Affairs at the Office of the United States Trade Representative (USTR). In his capacity as Director, Mr. Holloway is responsible for representing the United States on trade policy issues in the Committee on Trade and Investment within the Asia Pacific Economic Cooperation (APEC) forum. Mr. Holloway has worked on a variety of topics in APEC including trade facilitation, intellectual property, and issues related to small and medium-sized enterprises, among others.

From 2008 to 2009, Mr. Holloway worked as Director for Japan Affairs at USTR and was responsible for developing and implementing trade policy towards Japan. Prior to working at USTR, Mr. Holloway worked as a trade policy analyst at the U.S. Department of Commerce from 2002 to early 2008 focusing on electronic commerce and the information technology sector. In his time at the Department of Commerce and USTR, Mr. Holloway has worked on a diverse set of trade policy issues in bilateral and multilateral fora including APEC, the U.S.-Japan Regulatory Reform and Competition Policy Initiative, and the U.S.-India High Technology Cooperation Group. Mr. Holloway entered the U.S. Department of Commerce as a Presidential Management Fellow in 2002.

Mr. Holloway has a Master's Degree in Public Administration from the University of Southern California and a BA in Business Administration from the California State University at Sacramento.

Mr. Weston was involved in a number of negotiations, including in GATT/WTO, ANZCERTA, NZ-Singapore, NZ-China, NZ-Korea, ASEAN-Plus and Pacific Agreement on Closer Economic Relations (PACER). He is New Zealand's representative to the APEC Sub-Committee on Customs Procedures.

Chairman Edgardo B. Abon Philippine Tariff Commission Philippines

On September 15, 2010, His Excellency President Benigno S. Aquino, Jr., re-appointed Atty. Edgardo B. Abon effective October 11, 2010 as the Chairman of the Tariff Commission. His chairmanship started on April 6, 2001 with his appointment by then President Gloria Macapagal-Arroyo.

Chairman Abon is both a chemical engineer and a lawyer, earning his engineering degree at the University of the Philippines (UP) in 1973 and his law degree at the Far Eastern University (FEU). He was admitted to the Bar in 1990.

Before joining the Commission as a Member-Commissioner in 1996, Chairman Abon was a top official of Unilever Philippines (PRC), Inc., where he held various distinctive positions in production, marketing, sales, and research and development. His managerial skill in these fields earned him the leadership in the Industrial Marketing Group in 1985. This business unit was responsible for the business performance of the company's industrial products in the domestic market and for both industrial and consumer products in the exports market.

Chairman Abon pursued special studies on several select courses, including Industrial Marketing (1982), Strategic Marketing (1985) and Business Management (1991), at the Ashridge Management College in the United Kingdom.

Chairman Abon continues to be an active member of the Philippine delegation in regional and international tariff and trade negotiations/dialogues. He chaired the ASEAN working group that drafted the ASEAN Trade in Goods Agreement (ATIGA) in 2007. He participates in the NAMA and in Rules negotiations at WTO. He currently chairs the ASEAN Plus Working Group on Tariff Nomenclature (AP-WGTN) that explores possible ways to harmonize the tariff nomenclature of ASEAN with its FTA partners.

His personal advocacy is the adoption of an effective competition policy and the enactment of a comprehensive competition law in the Philippines. He is currently the Philippine representative to the ASEAN Expert Group on Competition (AEGC).

He is married and has three (3) children.

Atty. Louis C. Adviento Bureau of Customs Philippines

Atty. Adviento is the Chief Customs Operation Officer of the Export Division of the Bureau of Customs (Port of Manila).

He holds a Bachelor of Science in Criminology from the Philippine College of Criminology and a Bachelor of Laws from the Far Eastern University where he graduated class salutatorian. He ranked 13th place at the Philippine Bar Examinations in 1980.

Ms. Emmarita Z. Mijares Export Development Council Philippines

The EDC, a quasi-government institution, is the country 's highest policy making body in exports in charge of approving the Philippine Export Development Plan.
