As one of the agricultural cooperatives, we, JA-Group, believe "Cooperation with others" - farmers, consumers, cooperatives, and companies in local region-is vital for food security. Based on this point of view, we have implemented various activities. I would like to introduce some example cases.

#### What's JA?

"JA" stands for "Japan Agricultural cooperatives" and JA Zenchu, or the Central Union of Agricultural Cooperatives is the umbrella body at the national level that represents 710 primary agricultural cooperatives, their federations at prefectural and national level and 4.8 million member farmers all over Japan.

# Business Partnership with foreign agricultural cooperatives

- Agricultural cooperatives share the same ideal, which is, to protect and enhance their farmer member's production activities.
- We, as a agricultural cooperative, have continued stable business relationship with foreign agricultural cooperatives; import corns, soy beans and other feed to realize "sustainable livestock farming management" for Japanese livestock farmers.

### Cooperation with APEC member economies

- Most of the EPAs that Japan has so far concluded with APEC economies, contain a chapter on "Cooperation" as well as tariff reduction.

# Co-existence with Asian farmers and cooperatives

- We have participated in FAO "Tele Food Project" (fundraising) since 1997 and supported some projects such as school lunch in regions suffering from lack of nutrition, food processing business of women farmers groups.
- Since 2005, we have started a project named "Fundraising for Coexistence" with Asia" to further contribute to improvement of income, productivity and living standards of Asian farmers.

### Cooperation in times of disaster

- · Asia-Oceania region is frequently suffered from natural disasters.
- The Great East Japan Earthquake caused a tremendous damage on the center of Japanese agricultural production. After the disaster, we received heartful support from farmers from all over the world for recovery.
- Meanwhile, JA Group supported Thailand cooperatives for recovery from the flood which happened in the same year.

 We have shared our experience with farmers and other cooperative members from all over the world at various opportunities such as assemblies of ICA(International Co-operative Alliance), AFGC (Asian Farmers' Group for Cooperation) ,and WFO (World Farmers' Organisation)

#### An example of shared best practice: Relationships between farmers and consumers (in case of Japan)

We have built strong relationship with consumers based on mutual trust in Japan, which is mutually beneficial.

#### Food and agriculture education

- Deepening local citizens' understanding on food and agriculture through education.

#### Dialogue and joint activities with consumers' groups

- Exchange of views and promotion of mutual understanding
- Joint action on issues of mutual concerns such as agriculture, food safety, the environment and trade policies



- Regarding food security, we face many challenges not only at local level, but also national and international levels.
- To address these challenges, further accumulation and sharing of know-how are needed.
- As a cooperative consists of farmers, we will actively promote various activities represented by ones introduced in this presentation.

- Cooperation among farmers in APEC region
- -Dispatch of short-term experts (cultivation technique, services of agricultural cooperatives)
- -Support micro projects to expand food production and to improve people's lives in rural communities through the fundraising
- -Periodic meeting on the agricultural policy for example through AFGC (Asian Farmers Group for Cooperation)
