
TYPERIAND 1. Negotiate the L&I Texts


- Preamble
- Initial provisions and general definitions
- Dispute settlement
- General exceptions
- Institutional provisions
- Transparency
- General provisions
- Final provisions



NEW ZEALAND 2. Legal Advice

- 1. Understand WTO law and jurisprudence
- 2. Drafting clarity
 - ordinary meaning of the terms of the treaty (in context and in light of object and purpose)
 - only if ambiguity, then can look at preparatory work of the treaty and the circumstances of its conclusion
 - So what you thought you agreed to not always determinative!
- Drafting solutions







Panda: eats shoots and leaves



"Panda. Large black and white bear-like mammal native to China. Eats, shoots and leaves."



NEW ZEALAND Ambiguity

1994 Cairo Conference on Population, clause on abortion:

- 1. Abortion is unthinkable. Cannot be contemplated.
- 2. Abortion happens. Should be safe.
- "In those circumstances where abortion is not against the law, such abortion should be safe".



TYPE ZEMAND 3. Strategic Guidance

Part of core team (lead negotiator, legal adviser, FTA coordinator)

Overarching view:

- See linkages, connections not just within chapters, but between chapters
- Ensure coherence
 - rafting
 - negotiating



4. Legal Verification


- Following conclusion of the negotiations and before signing
- Final 'scrub' of the text
- Technical, non-policy issues
- Ensure consistency across the text
- Translation



- Domestic constitutional approval process for entering into treaties
- Legislation
- Entry into force
