



- Biz are not familiar with FTA issues



- Small biz often have short visions






#### They need information




## They need to be more capable

- -to understand the issues
- -to analyse their potential impacts
- -to make better arguments pro and contre

## Thus, technical assistance should be provided to biz in:

- raising awareness
- building capacity
- taking action together (through biz associations)



# They need to be inclusive in the implementation phrase as:

- The transmission from commitments into domestic rules might be a new occasion for biz
- The rules might have a real life different from those in the text
