

1. Scope of Application



Public Sector

Public officials | Heads and faculty members of public schools Heads and employees of public service-related institutions


Private Sector

Private schools | Journalists | Persons performing public duty


2. Prohibition of Improper Solicitation

Direct or indirect improper solicitations to public officials are prohibited

Ex.) Permit·license, remission of administrative disposition, intervention in personnel management, school admission, grades, investigation or trial



3. Prohibition of Money, Goods, etc.



Regardless of duty-relatedness, any financial benefits are banned

Duty-related financial benefits are banned

3. Exceptions | Prohibition of Money, Goods, etc.

- 1. Money, goods, etc. offered by public institutions or senior public officials
- 2. Foods, gifts and congratulatory or condolence money offered for facilitating public duties, social relationships, rituals or aids
- 3. Money, goods, etc. offered from a legitimate source of right
- 4. Money, goods, etc. provided by relatives
- 5. Money, goods, etc. offered in accordance with the rules of employee's mutual aid societies or social organizations or by those with close relationship
- 6. Transportation, accommodations or foods provided uniformly in a normally accepted at an official event
- 7. Souvenirs, promotional goods distributed, or prizes in a contest or a lottery
- 8. Money, goods, etc. permitted by other Acts, subordinate statutes, standards, or societal rules and norms

4. Punishment for Prohibited Acts



Administrative fine

Up to KRW 30 Million (\$30,000)

- Person making an improper solicitation through a third party
- Person making improper solicitation for a third party
- Public officials receiving less than KRW 1 million (\$1,000) regarding their duty, and the provider

Criminal punishment

Maximum 3 Years of Imprisonment or Fine of up to 30 Million (\$30,000)

- Public officials carrying out duties as solicited
- Public officials receiving more than KRW1milion (\$1,000), and the provider



Achievements in 1 year after enactment of the act

1. Enhanced Public Integrity Perception

"Customary practice of asking a special favor and giving entertainment is an improper act"



After the Act took effect, ethical sensitivity of the public has been enhanced

2. Reduced Corruptions

"Requests based on personal connections have dropped"



"Duty-related hospitality and gifts have decreased"



Improper requests and hospitality behind the scene have been reported and detected

Self-reported violations: 65%

Self-reported receipt of money, goods, etc.



3. Improved Business Environment


Entertainment expenses of Korea's 500 biggest companies have dropped

W 114.3 billion (\$114.3 million)






4. No Money Gifts in Schools


"Custom of giving money gifts to teachers have disappeared"
