Public Officials Property Declaration System

 The Act on Property Declaration by Public Servants is to require Some specific public officials to fill in the various property situations, such as deposits, real estate, claims, debt, securities, insurance etc., submit a written report to the designated supervisory authority for review and supervision.

Public Officers Property Declaration System

- The longer the system of property declaration is implemented, the lower the corruption index.
- that can effectively punish those who do not report it according to law, the lower the corruption index.

Public Officers Property Declaration System

- The more complete the check mechanism, the lower the corruption index.
- Property declaration the more publicly disclosed, the lower the corruption index.

Public Officers Property Network Declaration System

We hope that through the property declaration system, people's trust in the government can be enhanced.

Public Officials Property Network Declaration System

Ministry of Justice has set up the "Public Officials Property Network Declaration System "since 2010 to provide more convenience Property declaration work.

Public Officials Property Network Declaration System

 To enhance the service quality of the online application, Ministry of Justice has promoted the service of "public officers authorized to access property information" since 2014.

Public Officials Property Network Declaration System

 For those who apply for "regular declaration", the legal department may, through their own authority and spouse's authorization, Interview with more than 530 property inquiry agencies of property information, to provide Public officials for the current year when the declaration of regular property With reference to the application.

Public Officials Property Network Declaration System

 The Ministry of Justice set up this system, using software and hardware facilities instead of the paper-based declarations, significantly improving the efficiency of check-in and simplifying the reporting costs, highly regarded by public officials.

Based on the principles of government integration and resource sharing, Ministry of Justice and other relevant agencies have been developing and maintaining the information system for the declaration of property for public officials.

Public servants and their spouse authorize Minister of Justice(MOJ) to collect property information.

MOJ assist to collect information from 530 institutions

MOJ provide property information for public servants to download

After download and check these information, public servants shall finish property declaration within expiry date Public servants and their spouse authorize Minister of Justice to collect property information based on laws passed by the Legislature.

MOJ assist to collect information from 530 institutions, such as, financial institutions, land administration agencies, supervision systems, insurance companies.

MOJ provide property information for public servants to download

Specific public servants shall declare their properties

When to declare properties?

- the date of inauguration
- the date of being discharged
- annually property declarations

imposed with a fine:

- Properties declaration was overdue
- intentionally make untruthful declarations





 First, to provide convenience of online property declaration, reduce the burden on the reporting obligations

 Second, to reduce the reporting obligations of property information query time

 Third, to reduce the troubles, burdens and manpower input with the inquiring organ

 Enhancing the acceptance reporting organs to check the operation efficiency
