Financial Reports for APEC-funded Projects

(as at 31 December 2019)

 As a measure to increase the transparency in monitoring project expenditure, BMC decided in 2003¹ that financial statements for completed projects funded by the Trade and Investment Liberalisation and Facilitation Special Account (TILF) should be prepared by the Secretariat, and further in 2007² that the same arrangement be extended to all completed projects, regardless if they are funded by the General Project Account (GPA)³, the APEC Support Fund (ASF) or TILF.

Projects Completed / Expired

- This paper presents the settled accounts of the APEC-funded projects completed/expired between 1 January and 31 December 2019 for BMC's information and monitoring. The financial statements of the completed/expired projects funded by GPA, TILF and ASF are at Annexes A to C respectively.
- 3. In summary, a total of 119 standard projects were completed/expired in the full year of 2019, which were all within their approved budgets. Among them, 50 projects were funded by untied funds (i.e. GPA, TILF and ASF General Fund). Their approved budget on average was US\$110,375 per project, and their actual expenditure on average was US\$57,414 (52%), as shown in the table below. The unused project funding has been returned to the respective project funds for approval in subsequent project sessions.
