Work undertaken

Collaboration

During this period:

Institutional Matters

The PSU's financial sustainability remained an issue of deliberation by the PSU Board and Senior Officials. Among the suggestions raised were to discuss the issue at the Budget and Management Committee (BMC) meeting and in relation to members' contributions formula. The Report of the APEC Vision Group titled "People and Prosperity: An APEC Vision to 2040" (December 2019) also included a recommendation to address the long-term funding for the PSU to handle the post-2020 workload.

HR Matters

• <u>Interns</u>: The fourth intern was recruited - Mr Arief Rizky Bakhtiar of Indonesia (August-September) from the Lee Kuan Yew School of Public Policy in Singapore. Recruitment for 2020 interns commenced in November 2019.
