Chokepoint 1: Lack of coordinated border management and underdeveloped border clearance and procedures

Indicators	% of improvement (% of change)
DB Cost to Import (documentary and border compliance)	-4.6%
DB Time to Import (documentary and border compliance)	-13.6%
DB Cost to Export (documentary and border compliance)	-4.3%
DB Time to Export (documentary and border compliance)	-11.8%
Trading Across Borders Score	+2.1%



Integrating SMEs in Authorized Economic Operator Certification: Improving SME Participation in APEC Secure Trade

Chile and Chinese Taipei collaborated to facilitate the integration of SMEs in AEO certification by enhancing awareness and understanding of opportunities and benefits for AEO operators. Two workshops and three studies were conducted for this purpose.

Transportation Infrastructure Development

Promoting Quality Infrastructure Investment in rapidly urbanizing APEC Region project discussed challenges in enhancing quality infrastructure investment and smart city development.

Public-Private Partnership (PPP)

The Peer Review and Capacity Building on APEC Infrastructure Development and Investment project highlights the importance of PPP in infrastructure development and investment.

APEC Initiatives & Case Studies

APEC Green Supply Chain Cooperation Network

The APEC Cooperation Network on Green Supply Chain encourages economies to develop green supply chain pilot centres, and boost cooperation in the area of green supply chain, green production and consumption and green trade.

National Logistics Ecosystem (NLE)

Indonesia established the National Logistic Ecosystem with the objective of harmonising the flow of goods and information across supply chains.

Structural Reforms in Logistics Services

The multi-stakeholder dialogue was conducted in Viet Nam in 2018 to exchange information on structural reforms among policy makers, regulators, businesses and related associations.

Digitalisation of Air Freight Logistics

The Digitalization of Air Freight Logistics Pilot Project at Xiamen airport comes as part of a two-phase project to connect stakeholders in the air freight logistic chain. It aims to shift to paperless transportation processes and connect systems for information sharing.

Chokepoint 4: Limited regulatory cooperation and best practices

Alliance for Supply Chain Connectivity (A2C2)

Provides guidance and technical inputs on capacity building programs and providing future direction on supply chain work in APEC.

APMEN Visualization of Sea Freight Logistics Project

The APMEN Visualization of Sea Freight Logistics project helps to develop comprehensive data standards to support the exchange of critical sea freight data and provide recommendations regarding the use and implementation of data standards for e-Port visibility.

Export Certificate Roadmap

The United States developed a roadmap in 2013 to reduce unnecessary certification requirements and harmonise international certification standards.

Peru Technical Assistance on Publication

Using the SCFAP sub-fund, the United States implemented assistance to develop a trade information portal within Peru's Domestic Single Window of Foreign Trade to fulfil commitments in WTO TFA Article 1.1 (Publication).
