1. OBJECTIVES

Digital economy is key phenomena at the current stage of global development. The use of digital technologies contributes to the economic development and trade facilitation and ensures the inclusive nature of regional production and trade. Information technology (IT) sphere has opened the opportunities to lower distribution costs and enlarge the market for content-related businesses. Recently, there has been surge in the ability of consumers and businesses to reach the Internet and to engage in digital content trade and e-commerce.

However, the absence of Intellectual Property Rights (IPR) protective mechanisms lead to higher vulnerability of creations on the Internet. The processes of copying or altering digital information have become easier and more available with the IT development. In this regard, violation of IPRs is one of the key impediments for digital content trade. There are challenges to protecting intellectual property in the digital environment that need to be tackled timely at both domestic and international level. APEC economies' individual and joint efforts should also be focused on the development of transparent and efficient regulatory environment, which enables trade in digital content and related business activities, while ensuring that intellectual property rights are respected.

The objectives of the workshop are:

- 1. To examine existing challenges APEC economies are facing in the field of IPR protection in digital content trade;
- 2. To facilitate better understanding among APEC economies of how the issues relating to IPR protection in digital content trade are regulated on international, regional and domestic level;
- 3. To review APEC economies best practices and exchange experiences in promoting effective protection of IPR in digital content trade.

The workshop will include several sessions with varying dynamics such as expert presentations and panel discussions followed by the audience Q&A sessions.

6. METHODOLOGY

(6.1) Organization of Program

Target audiences of this project are:

Primary beneficiaries are government officials in charge of intellectual property rights in APEC economies who can enrich their knowledge related to the legal gaps in the field of IPR protection in digital content trade, both at domestic and international level. It will also help to get acquainted with possible approaches to address current challenges in this area. The primary target participants of the event are government officials (e.g. CTI members). Secondary beneficiaries are businesses, including MSMEs, because the workshop could provide them with more information on the IPR protection facilitating their further integration in digital content trade. Thus, participation of representatives of private sector, including MSMEs involved in digital content trade is strongly recommended.

Economies are also strongly encouraged to consider qualified female participants in their nominations.

(6.2) Evaluation

Participants are required to complete and return an Evaluation Form by the end of the workshop. In this form, each participant is encouraged to share their views and advice on the Workshop's impact and efficiency as well as possible suggestions and policy implications for future APEC related cooperation programs and activities.

(6.3) Language
