#### DUAL COMPETITION

- Through the granting of patents, utility models, industrial designs, trademarks, trade names, commercial notices, appellations of origin and trade secrets.
  Formally and materially administrative
- Revertheless, through the Divisional Direction of Protection of Intellectual Property, it also issues formally administrative and materially jurisdictional acts, because it settles disputes between individuals.
- This is through what is called administrative declarations (of nullity, expiration, cancellation, infringement and infringement in trade matters).








#### ENFORCEMENT ACTIVITIES



# Legal Reform for the Protection of the Intellectual Property Rights

REFORM TO THE PROTECTION OF INTELLECTUAL PROPERTY SECONOMÍA RIGHTS

01 Electronic Notifications.

Hybrid procedure aimed at one as electronic as reality deserves.

02 Provisional Measures in the Digital Environment.

Acts of IPR protection according to reality.

- 03 Provisional Measures in **Transshipment**the acts of the IMPI in defense of IPR.
- 04 Sanctions increasement.

High financial penalties in order to generate a dissuasive effect for future infractions.

#### 05 Conciliation Procedure.

First Alternative Means of Dispute Resolution provided in Mexican legislation on Industrial Property. Administratively, a civil law is regulated. 06 Study to order and to impose provisional measures.

From a review of requirements to a legal study of minimum evidentiary requirements.

#### Damages.

Provenance assumptions are expanded, conditioning factors are eliminated and specific parameters are offered to obtain compensation.

#### **08** Destruction of goods.

Agility in the process.

09 Nullities and partial expiration dates the products or services.

#### **10** Technological Protection

**Measures**ayer that prevents the use of a work without authorization of the owner.

#### **11** Notice and Take Down. Internal guidelines of digital platforms.

# Intellectual Property in the digital age



Request for provisional measures online Copyright protection was requested against the owner or person in charge of several websites.

#### Problematic

The imposition of measures by IMPI was contested by the **Internet Access Providers**, who considered that the principle of neutrality of the networks was attacked.

#### Decisions of the SCJN (Supreme Court) The SCJN defined the guidelines regarding the proportionality of the measure, considering the following:

ECONOMÍA

• The IMPI, has among its powers, to order provisional measures to PAI to blocki the content on the web pages.

According to the SCJN, for provisional measures to be in accordance to the parameter of constitutional regularity, they must:

- **01 BE PROVIDED IN LAW.** Now they will be expressly.
- 02 BE BASED ON A LEGITIMATE PURPOSE. To carrying out the study of the appearance of good law that shows the intellectual property rights are protected.
- **03 NECESSARY AND PROPORTIONAL.** With the lessons learned, absolute blocking orders are not envisaged, but orders proportional to the protected right.

## NEW VISION IN THE PROTECTION OF RIGHTS IN THE DIGITAL AGE



Article 332.- In the procedures related to the alleged violation of any of the rights protected by this Law, the Institute may adopt the following measures:

ECONOMÍA

VII.- Order the alleged offender or third parties to suspend, block, remove content or cease acts that constitute a violation of this Law through any virtual, digital or electronic means, known or to be known,

#### Inspections in virtual establishments.

Article 347.- Inspection visits are those carried out in the places where products are manufactured, stored, transported, sold or marketed or where services are provided, in order to examine the products, the conditions of provision of the services and documents related to the activity in question, whether in physical or virtual establishments.
