### The Health Working Group's Work Plan for 2021

#### Introduction

The COVID-19 global pandemic has exhibited how a health issue can quickly have detrimental impacts to an economy's populations and economic future. Since the start of the pandemic, the APEC region has recorded about 15 million cases and almost half a million deaths from COVID-19, equivalent to 37 percent of global deaths<sup>1</sup>. Although the APEC region recorded real GDP growth of 3.6 percent in 2019, the economic impact of the COVID-19 pandemic resulted in negative real GDP growth rate and a staggering output loss of USD 2.9 trillion.<sup>2</sup>

While responding to COVID-19 member economies are also working to maintain other essential health services across the life course. However, prevention and treatment services for both infectious and non-communicable diseases (NCDs) have been increasingly disrupted as the implementation of public health measures to mitigate community transmission of the virus continues to affect access and delivery of key health services and programs.

In addition, COVID-19 has exposed and exacerbated existing challenges faced by our health systems, including barriers to access healthcare and health services. It has also raised social and economic inequalities, which have been magnified by the disproportionate impact of the crisis on the poor, women, children, Indigenous peoples and others in vulnerable and at-risk situations.

Nonetheless, the pandemic has resulted in innovation in the research and development of medical countermeasures, as well as the use of digital technology and tools to help overcome our current constraints. While the implementation of these solutions were as a result of our current challenges faced by our economies in the short term, they will provide the basis for positive improvements to our health systems in the long term.

It has been estimated that recovery is expected to begin in 2021 with GDP growth projected at 5.2% in the APEC region.<sup>3</sup> However, recovery hinges on what policies are implemented to contain the virus and start rebuilding our economies. In addition, we must reflect on how to continue our progress in moving towards achieving universal health coverage (UHC) the 2030 Agenda for Sustainable Development.

In accordance with the Strategic Plan 2021-2025, the APEC Health Working Group (HWG) aims to reduce the impact of health-related threats to the economy, trade and security of member economies, and to strengthen health systems to increase their efficiency, responsiveness and resilience to achieve and maintain universal health coverage. For instance, following the emergence of COVID-19 in 2020, the APEC HWG facilitated important discussions to assist the APEC region in responding to the crisis, including a roundtable discussion in February, the development of a COVID-19 statement in March and further discussions on COVID-19 response in September.

Consequently, the HWG, within APEC, can facilitate the collaboration and information exchange needed to: 1) support the development of policies to contain the virus, 2) rebuild our economies, and 3) achieve UHC and the 2030 Agenda; while supporting and aligning with the work of key partners such as the World Health Organization.

For 2021, the HWG's theme will be "Response, Rebalance, Recover. Together" This theme seeks to complement the APEC 2021 theme "Join, Work, Grow. Together".

For 2021, the HWG's mandate will be actualized through activities focused on:

- 1. **Response**: As the region continues to respond to increases in cases of COVID-19 and the emergence of new strains of the virus, the HWG will continue to respond to the COVID-19 pandemic by facilitating prevention, surveillance, containment and treatment efforts, while integrating equity, diversity and inclusion throughout the response. This will also include cooperating on various aspects related to COVID-19 medical countermeasures and exploring the impacts to vulnerable and at-risk communities.
- 2. Rebalance: The continuous threat from other current and emerging infectious diseases, as well as the growing and overwhelming burden from non-communicable diseases continues to impact our health systems. In some instances, the emergence of COVID-19 has exacerbated these diseases. The HWG will focus on balancing responding to the pandemic, while also refocusing on other health issues, supporting healthy populations across the life course, including those health issues from the 2020 Work Plan that were deferred due to the emergence of COVID-19.
- 3. **Recover**: Moving forward, we must continue to strengthen and support implementation of a "Health in All Policies", "whole-of-society" and coordinated regional approach. The HWG will focus its efforts on enhancing preparedness, response and recovery for public health emergencies. It will also explore the development and contribution of digital health technologies in safeguarding people's health and protecting the region from health threats, as well as enhancing the resilience, scalability and sustainability of health systems, thereby moving towards universal health coverage and equitable economic growth.

**4. Together:** COVID-19 has demonstrated the importance of international cooperation to overcoming global challenges. The HWG will focus on working together to share knowledge and experiences on all three themes (Response, Rebalance and Recovery), as well as discuss how the HWG can support those efforts within APEC, regionally and globally. The HWG will encourage and facilitate collaboration with other APEC fora on the three themes, particularly given the multi-sectoral nature of the COVID-19 response. Furthermore, the HWG will seek to support and align with efforts of other global, regional and multilateral bodies on COVID-19 efforts.

The HWG recognizes the importance of gender-based analysis in strengthening health systems and encourages HWG member economies to include a gender-based lens in their activities. Women are positive agents of change in efforts to advance health for all, including in their roles as decision-makers, leaders, innovators and caregivers.

### 2. Policy/Technical Deliverables:

### **HWG Deliverables**:

2.1. Vaccination Program of Work 2020-2021

Rationale: Following the re-emergence of vaccine-preventable diseases across the APEC region in 2018 and 2019 and a renewed focus on vaccination within the HWG, the HWG agreed to coordinate and build on existing efforts on vaccination in the HWG and promote a cohesive, longer-term approach to related initiatives. The Vaccination Program of Work (VPoW) 2020-2021 outlines planned initiatives addressing both the demand side (vaccine acceptance and uptake) and the supply side (improving vaccine supply chains). Due to the anticipated increased focus on vaccination in 2021 and 2022, it is recommended that the Vaccination Spotlight Report and Policy Workshop (Policy Options for Addressing Digital Literacy) be deferred to 2022, to ensure COVID-19 vaccination efforts are reflected.

## 2.1.1. Policy Discussion: COVID-19 Vaccination – Roll-out and Addressing Vaccine Confidence (February 2021 – SOM1)

<u>Description/Rationale</u>: The issue of "vaccine hesitancy", or individuals' delayed acceptance or refusal to be vaccinated despite the availability of vaccines, due to lack of confidence, has been escalated further by the emergence of COVID-19, accompanied by misinformation, and the new vaccines that have been developed as a response. In addition, given the limited supply of vaccines in the short to medium term, economies are having to prioritize and ensure equitable access to at-risk and vulnerable populations.

In alignment with the VPoW and the APEC Action Plan on Vaccination Across the Life-Course, the HWG will have a Policy Discussion during the first HWG meeting to discuss experiences with COVID-19 roll out, the role digital literacy has played in addressing vaccine confidence and how economies can ensure equitable access to its most vulnerable and at-risk populations. The discussion will seek to facilitate HWG collaboration and the exchange of information to support the development of domestic policies related to vaccine confidence initiatives and overall COVID-19 vaccination efforts.

# 2.1.2. Policy Discussion: Protecting Gains from Immunization Programs in the Control of Vaccine Preventable Infectious Diseases (August 2021 – SOM3)

<u>Description/Rationale</u>: The COVID-19 response has diverted resources away from national immunization programs, debilitating long time efforts to control vaccine preventable diseases. In alignment with the VPoW and the APEC Action Plan on Vaccination Across the Life-Course, the HWG will have a Policy Discussion during the second HWG meeting to discuss how to protect the region's immunization efforts to control vaccine preventable diseases, which have been disrupted by the COVD-19 response. The discussion will be supported by officials from the regional offices of the WHO. The discussion will aim to facilitate the exchange of

information to support the need to protect domestic immunization efforts and opportunities for streamlining with COVID-19 vaccination efforts.

### 2.2. Policy Discussion: Addressing Non-Communicable Diseases Across the Life Course (March 2021 – SOM1)

Description/Rationale: According to the World Health Organization, 7 of the 10 leading causes of deaths in 2019 were due to NCDs. NCDs also accounted for 74% of deaths globally in 2019. NCDs, including cardiovascular diseases, diabetes and cancer, also put individuals at increased risk of complications related to COVID-19. However, prevention and treatment services for non-communicable diseases (NCDs) have been increasingly disrupted as the implementation of public health measures to mitigate community transmission of the virus continues to affect access and delivery of key health services and programs. In addition, the pandemic has disrupted or halted critical mental health services while the demand for mental health is increasing. This will have long term effects for our health systems for years to come. As a result, the HWG will hold a discussion to provide an opportunity for member economies to share their experiences and perspectives in addressing NCDs, while also addressing COVID-19, and how they have been able to address the needs of at-risk and vulnerable populations. The discussion will be supported by officials from the regional offices of the World Health Organization, as well as the International Agency for Research on Cancer, who will provide overview presentations of NCDs in the regions, before member economies begin a guided discussion. The discussion will seek to facilitate the exchange of information to support continued domestic efforts to address NCDs.

# 2.3. Development and Endorsement of "Good Practices on Public Policies in Childhood Nutrition" (August 2021 – SOM3)

Description/Rationale: Malnutrition in all forms costs the global economy approximately US\$ 3.5 trillion per year, with overweight and obesity alone costing US\$ 500 billion per year. Through its effects on health, malnutrition increases health-care costs, reduces productivity and slows economic growth, which in turn can perpetuate a cycle of poverty and ill health. In addition, the years 2016 – 2025 have been proclaimed the United Nations Decade of Action on Nutrition, presenting an opportunity to address all forms of malnutrition. As agreed during SOM1 2020, the HWG will work to develop a compilation document of best practices to address childhood nutrition, both obesity and malnutrition, across the Asia-Pacific region, and support the region's capacity to share knowledge and experience in addressing this important issue. This effort will be led by the sub-working group on Childhood Nutrition led by Chile.

### 2.4. Development and Endorsement of "Good Practices for Healthy Ageing" (August 2021 – SOM3)

<u>Description/Rationale</u>: 2021 marks the beginning of the United Nations Decade of Healthy Ageing (2021-2030) to catalyze and collaborate on action to improve the lives of older people, their families, and the communities in which they live. Furthermore, the APEC region includes some of the most rapidly ageing populations in the world. For instance, a third of all APEC economies are projected to be "super-aged" within the next decade, meaning more than a fifth of their population will be older than 65 years of age. As discussed during SOM1 2020, the HWG will work to develop a "Document on Good Practices for Healthy Ageing". This effort will be led by the sub-working group on Healthy Ageing led by Chile.

# 2.5. Publication and Launch of the HWG 'Dementia Spotlight': A Compilation of Initiatives to Address Dementia in the Asia-Pacific Region (March 2021 – SOM1)

Description/Rationale: The global societal cost of dementia is approximately US\$ 818 billion and the number of people living with dementia in the Asia-Pacific region is expected to triple between now and 2050. While dementia is not a normal part of aging, it mainly affects older people and is one of the major causes of disability and dependency among the global aging population. Moreover, older age often exacerbates pre-existing inequities based on income, education, gender and urban/rural residence, highlighting the importance of equity-focused policy-making. Population aging requires collaboration across sectors to address the underlying determinants of health of older people, including housing, transport and the built environment. As agreed to during HLM9, the HWG will finalize the development of a 'Dementia Spotlight Report' which will facilitate the sharing of successful policies and programs across the region to encourage collaboration between APEC economies. The Report will also be submitted as a regional resource to the WHO's Global Dementia Observatory knowledge exchange platform and will seek to strengthen the HWG's partnership with the WHO, the International Federation on Ageing, and Alzheimer's Disease International.

# 2.6. Policy Discussion: Leveraging Digital Technologies to Address COVID-19 and Sustain Innovation to Support Health Systems (August 2021 – SOM3)

<u>Description/Rationale:</u> The development and contribution of digital health technologies in response to COVID-19 has revealed its importance in safeguarding people's health and protecting the region from health threats. Moreover, these technologies have the potential to positively change aspects of the healthcare sector, enhancing the resilience, scalability and sustainability of health systems, thereby moving towards universal health coverage. It is recommended

the Policy Dialogue Workshop will be conducted in 2021, and the discussion will also lead to the development of a report on the Best Practices in Digital Health Innovation in Response to COVID-19, to share expertise both within the APEC region and more globally.

### 3. <u>Cross-Fora Deliverables</u>:

3.1. Post-2020 APEC Roadmap to Promote Mental Wellness in a Healthy Asia Pacific (February 2021 – SOM1 and August 2021 – SOM3)

Description/Rationale: The promotion of mental health, both within and outside of the health sector, is a shared responsibility that requires the active participation of all sectors and actors, on local, global and national levels. COVID-19 has underscored the importance of inclusive mental health services and psychosocial support into all aspects, and all levels, of preparedness and responsive activities for current and future public health emergencies. In addition, it has underscored the gaps that exist in our mental health systems and demonstrated important lessons in building these services for the future. Given the expiry of the APEC Mental Health Roadmap in 2020, the HWG will work alongside the APEC Life Sciences and Innovation Forum (LSIF) and the APEC Digital Hub for Mental Health to endorse a process for the development of a post 2020 Roadmap at the first HWG meeting, and endorse the Roadmap at the second HWG meeting. The post 2020 Roadmap will seek to strengthen mental health and reduce the economic impact of mental illness in the Asia-Pacific across the life course. It will also complement the extension of the WHO's Comprehensive Mental Health Action Plan to 2030.

3.2. Joint Emergency Preparedness Working Group (EPWG) and HWG Policy Dialogue – Strengthening Health Systems Resilience: Post COVID-19 (August 2021 – SOM3) (TBC)

<u>Description/Rationale</u>: Resilient health systems are key to preparedness and response to emergencies as all disasters are health issues, affecting the health of the population and bringing about substantial loss and disruption to public health systems, as has been demonstrated by COVID-19. Emergency preparedness is a key element of APEC's human security agenda and building disaster resilience is central to the achievement of the 2030 Agenda for Sustainable Development. The HWG will work together with the Emergency Preparedness Working Group to host a Policy Dialogue on strengthening health system's resilience, taking into account ongoing global reviews of the global response to COVID-19. WHO Regional Offices, ASEAN, PECC and PIF will also be invited to participate and

contribute to the discussion. The Policy Dialogue will seek to highlight the economic value and return on investment for strengthening pandemic preparedness to support future investments and policies.
