Brief Description of Project -- its purpose and the principal activities (including when and where):

E-Authentication is an essential infrastructure to secure e-commerce transactions. From executing the previous project -- "APEC TEL PKI/e-Authentication Training Program", conducting the annual PKI/e-Authentication Advancement Survey, and hosting APEC TEL PKI/e-Authentication Training Program, we find that there are lots of barriers to promote PKI (which represents one of the mature technologies in the field of e-authentication), and policy makers are the key to a successful implementation, and there are developing economies needed help to expedite the advancement in e-government and e-commerce applications.

The key to effectively and efficiently promoting the proliferation of e-authentication to manage the security and safety of digital identities in an economy is to encourage a long-term strategy of capacity building from the foundation, and what we could do at APEC TEL is to initiate an approach to help globalize the experience of "APEC TEL PKI/e-Authentication Training Program". **Now focus on "e-authentication" in general so as to include newer approaches/standards and share new technologies with participants at the initiative workshop.**

To enable realization of quick proliferation, deployment APEC wide, and long-run, continuous and effective strategic commitments to proliferation by all interested economies, especially developing economies within APEC region, in need of APEC fund. If the experience of training program can be learned, a long-term strategy of capacity building can be resulted in recommendation for joint efforts on further development to harmonize into a unique approach among regions in forming up properly sustainable supports. To be of significant impact, benefit and influence, "Train the Trainer Workshop on e-Authentication" aims to strategically enable seed instructors with trainer skills to deploy e-authentication training program in his/her economy, and help reduce the secured information and communication technologies (ICT) gap between developed and developing member economies. The proposal is for a project to strategically hold a "Train the Trainer Workshop on e-Authentication", to enable continuous proliferation of e-authentication in different aspects/models, in different developing economies, in the long-run.

It is scheduled to be held in Taipei in Q4, 2010(during October or November, the actual schedule will depend on the availability of the host venue). 2 per travel-eligible economy, a total of 15-22 targeted to be trainers are selected from the government sectors, academia, research institutes, and private sectors, based on the urgent demand of proliferation of e-authentication. The workshop is an interactive one, with simulations, group discussions and exchanges on execution. Besides "APEC TEL PKI/e-Authentication Training Program", holding the initiative Train the Trainer workshop on e-Authentication allows:

- Feasible strategies and cooperation to enable globalizing the experience of "APEC TEL PKI/e-Authentication Training Program".
- Commitments to a long-term strategy of capacity building, and the ongoing support to secured ICT are expected. Such as forming an experience sharing networking, building up training material database, developing a training tool, devoting to cooperation on secured ICT.
- Participants who have commenced implementation after the preliminary training program to return for further clarifications and discussions. They can also contribute to the workshop by sharing their experience in proliferation of e-authentication with others.
- Lecturers to better customize the session to meet the specific needs of APEC economies following the survey on "the intention to a long-term strategy of capacity building in proliferation of e-authentication" conducted before the enlistment.
- A manageable workshop to facilitate in depth discussion and exchanges between lecturers and participants.

Each application needs to complete a survey form which is to confirm "the intention to a long-term strategy of capacity building in proliferation of e-authentication". The applicants should show his/her potential trainer capabilities in the application materials, and commit to feedback the on-going or the further practice at the workshop. The lecturers will lead the discussion, help point out the key issues, and effectively transfer trainer skills. "Trainer's Manual" will be delivered, and provided in order to help the participants to expedite proliferation in his/her economy, and the experience of "APEC TEL PKI/e-Authentication Training Program" can be therefore deployed in APEC region.

A. <u>Project Design</u>

Project Objectives

The project is to meet capacity building needs for APEC developing economies. It will contribute to APEC's capacity building in response to "A New Commitment to Asia-Pacific Development" highlights the importance of reducing the gap between developed and developing member economies in 16th APEC ECONOMIC LEADERS' MEETING, 2008, and "Strengthening Cooperation and Capacity Building in APEC", APEC's program of Economic and Technical Cooperation (ECOTECH) -- the Development of Knowledge-Based Economies which is essential to achieving our objective of building capacity in a range of sectors in APEC economies. The commitment to the Manila Framework -- Developing Human Capital, Strengthening Economic Infrastructure, Harnessing Technologies for the Future which serves as the basis for the implementation of the ECOTECH activities outlined in the Osaka Action Agenda. For all member economies receive a quality education is critical to achieving social, individual, economic and sustainable development. It enables people to take advantage of the opportunities created by globalization. This project will help the APEC region including ongoing support to secured information and communication technologies (ICT).

This project is in line with the program of action of activities that launched by TELMIN6 in Lima, Peru in June 2005 as followings.

- 1. Advancing Information and Communications Infrastructure
- 2. Enabling Digital Opportunities through Effective Policy and Regulation
- 3. Advancing the Information Society through Human Capacity Building
- 4. Communication Networks for Disaster Mitigation and Relief Operation

In response to the instruction by Senior Officials in March 2005, the TEL has developed a future action plan to complement the e-APEC Strategy and to meet the Brunei Goals (TEL Chair) - the ultimate goal of universal Internet access by 2010. To further assist APEC economies meet the Brunei Goals, the TEL has agreed to:

- 1. Implement the APEC TEL Ministers 2005 Program of Action.
- 2. Support policies and regulations that promote the deployment of affordable and appropriate broadband infrastructure.
- 3. Encourage policies and regulations that support investment in both existing networks and alternative platforms.
- 4. Promote an open and transparent dialogue between all stakeholders.
- 5. Undertake human capacity development activities, to improve access, awareness, mastery, and application of ICT for the people of the region.
- 6. Seek APEC-wide recognition, including by APEC Leaders, of the importance of the "Key Principles for Broadband Development in the APEC Region".

And according to APEC TEL Ministers in the 2005 Program of Action, one of the actions is to encourage the development of policy approaches to enable the implementation and application of advanced technologies and services to expand access to unserved and underserved areas.

The key objectives of this project are following

 To deploy the workshop model to economies with high demand for trainer skills in eauthentication.

- To organize resources among sponsoring economies in local, regional and APEC Level and develop collaborative website for sharing and exchanging practices, knowledge and skills.
- To intentionally promote "Train the Trainer" approach within APEC and build up experience sharing networking among APEC member economies, and that is, to globalize the experience of "APEC TEL PKI/e-Authentication Training Program"

This proposed project would benefit the government, academia, research institutions and business entities. All APEC economies would be able participate to discuss better deployment and utilization of e-authentication, and benefits from equipping with the trainer skills to proliferate e-authentication.

Participants from the government, academia, research institutions and business entities will have the capability to train the local trainees and effectively execute the related promotion projects at hand, and be able access to the information networking among member economies.

The Government & Business Entities will be able to exchange the information and opportunity of IT capacity building for e-authentication implementation in e-government and e-commerce development.

Academia & Research institutions will have collaborations among teachers and researchers of member economies in sharing domain knowledge materials, best practices and valuable experiences.

In Hanoi in 2006, APEC Ministers extended this APEC tradition by encouraging "member economies to more deeply engage in building information and communications technologies (ICT) infrastructure and capacity to support strong efforts made in reaching the Brunei Goals on Internet access in the region," and welcoming APEC's collaboration with the private sector to "develop a framework for ICT-enabled growth in the region." The ICT-enabled growth initiative is designed to assist APEC economies in promoting the use and development of ICTs as a means to enhance their ability to participate in the global digital economy. The project is related to the six "I's" actions in the Digital Prosperity Checklist:

I. Infrastructure

- -- Communications
 - 8. Adopt security policies consistent with the 2002 APEC Cybersecurity Strategy and the 2005 APEC Strategy to Ensure a Trusted, Secure, and Sustainable Online Environment applications infrastructure;

II. INTELLECTUAL CAPITAL

- -- Skills and Capacity Development
 - 2. Emphasize vocational training programs to develop skills in management of an ICT workforce and ICT enterprise.

V. INFORMATION FLOWS

- -- Trusted Environment
 - 1. Implement policies to promote a trusted, secure, and sustainable online environment, consistent with the 2002 APEC Cybersecurity Strategy and 2005 APEC Strategy to Ensure a Trusted, Secure, and Sustainable Online Environment, including with respect to emerging technologies.
 - 4. Promote policies that increase security and authentication in electronic documents and transactions.
 - 5. Explore public-private partnerships related to securing elements of the online environment that have an impact on economic security.
- 7. Adopt policies that foster the adoption and deployment of electronic or digital signature technologies.

A variety of issues on PKI standard, technology, policy issues had been done at e-Security Task Group (eSTG), Business Facilitation Steering Group(BFSG), APEC TEL. After the transformation of eSTG, TEL, Security and Prosperity Steering Group (SPSG) was formed at TEL 33. "APEC TEL PKI/e-Authentication Training Program" proposed by Chinese Taipei was approved at SPSG, TEL 34. Since 2006, 4 International PKI/e-Authentication Training Programs were held by AEPC TEL PKI/e-Authentication Training Center in Chinese Taipei and enabled 84 attendees experience sharing, and those programs have helped promote the proliferation of PKI/e-Authentication to manage the security and safety of digital identities.

APEC Guidelines for Secure International E-Commerce Transactions completed by TEL is being utilized in lots of projects at the Electronic Commerce Steering Group (ECSG). ECSG continues relevant work to implement APEC's Strategies and Actions toward a Cross-Border Paperless Trading Environment to enable the electronic transmission of trade-related information across the region by 2020. Secure exchange network and PKI mutual recognition have been implemented in pilot programs:

- •Ensuring the implementation of the existing APEC Pathfinders:
- -e-SPS, ECO, Revised Kyoto Convention
- •Proposing new pathfinders for other priority areas:
- -cross-border electronic transmission of customs clearance data for express consignment based on WCO customs data model, followed by further initiatives for air cargos and ocean-going cargos

8) **Active Participation** Describe how the intended beneficiaries among APEC stakeholders – APEC fora, governments, private sector and civil society, men/women will participate in the planning, implementation and evaluation of the project.

All APEC member economies can participate in the project. The government, academia, research institutions and business entities in the APEC economies are strongly encouraged to participate in this initiative workshop. They may also suggest relevant discussion topics, implementation and evaluation of the project.

The workshop which will be conducted in Q4, 2010, will be planned to invite 15-22 from traveleligible economies, the government, academia, research institutions and private sectors. The participants should show his/her active participation in the workshop and this approach is expected to be deployed to other areas in APEC.

9) **Project influence** Describe how this project might contribute to any current or completed projects or activities in APEC or elsewhere. Why is APEC the most appropriate institution to fund the project?

"Train the Trainer Workshop on e-Authentication" will help enhance cooperative networking on effective proliferation of secured ICT infrastructure and e-Services integration, which is also related to activities that the Telecommunications and Information Working Group (TEL) continues its efforts to expand collaboration in dealing with issues of electronic security, to build confidence in the use of electronic networks, and to support policy and regulatory reforms that facilitate competition and the expanded reach of networks in e-APEC strategy.

Build upon the results of those previous projects:

1. "APEC TEL PKI/e-Authentication Training Program"

Since 2006, 4 International PKI/e-Authentication Training Programs were held and enabled 84 attendees experience sharing, and those programs have helped promote the proliferation of PKI/e-Authentication to manage the security and safety of digital identities. There are some previous participants of training programs, especially policy makers, demanding effective PKI/e-Authentication promotion while executing related projects. According to the 'PKI/e-Authentication Advancement Survey", the barriers of PKI Promotion include: 1) Application procedures are too complicated. 2) The cost of PKI implementation is too high. 3) The PKI market is still immature. 4) Civilian and enterprises still lack PKI knowledge. 5) Technical support issues are concerned. 6) Cultural acceptance of personal PKI and privacy concerns. 7) The PKI Promotion by the government is not enough. These indicate that even though PKI is recognized as a mature technology, its promotion is definitely not quite easy.

Capacity building in PKI/e-Authentication is demanding in developing economies. Since 2006, only 1/3 of the applicants could be admitted to the training program. The total investment of 7 training programs (2006-2012) by Chinese Taipei will be over 600,000USD.

2. Practices at ECSG, APEC

ECSG continues relevant work to implement APEC's Strategies and Actions toward a Cross-Border Paperless Trading Environment to enable the electronic transmission of trade-related information across the region by 2020.

Secure exchange network and PKI mutual recognition have been implemented in pilot programs: •Ensuring the implementation of the existing APEC Pathfinders:

- e-SPS, ECO, Revised Kvoto Convention
- •Proposing new pathfinders for other priority areas:
- cross-border electronic transmission of customs clearance data for express consignment based on WCO customs data model, followed by further initiatives for air cargos and oceangoing cargos

APEC is the most appropriate institution to fund the project :

Chinese Taipei initiates the new proposal in order to effectively globalize the experience of training program, and it is expected that the developing economies shall find better models to build-up the infrastructure of e-Authentication on their own in the long run, if "trainer the trainer" approach is deployed and supported by APEC.

"APEC TEL PKI/e-Authentication Training Program" is a preliminary training program, which aims at advancing PKI/e-Authentication awareness and strengthening related capabilities. While "Train the Trainer Workshop on e-Authentication" is an advanced approach, targeting on globalize the experience of "APEC TEL PKI/e-Authentication Training Program", and effective "Train the Trainer" on e-Authentication will help effectively shorten the ICT gap between developed and developing member economies.

APEC TEL PKI/e-Authentication Training Program" is from 2006 to 2012, initiated in APEC TEL 34, and held yearly with preliminary training courses, plays as a basis before "Train the Trainer" approach in the new project. There is an old saying "Teaching a man how to fish is better than giving him a fish". There are bold models to drive e-authentication proliferation at scale.

Now the new project is focused on e-authentication in general so as to include newer approaches/standards and share new technologies with participants at the initiative workshop.

To enable realization of quick proliferation, deployment APEC wide, and long-run, continuous and effective strategic commitments to proliferation by all interested economies, especially developing economies within APEC region, in need of APEC fund.

If the experience of training program can be learned, a long-term strategy of capacity building can be resulted in recommendation for long term joint efforts on further development to harmonize into a unique approach among regions in forming up properly sustainable supports.

To enable long-run, continuous and effective strategic commitments to proliferation, deployment APEC wide, by all interested economies, especially developing economies in need of APEC fund, therefore, APEC will be the most appropriate institution to fund the project -- "Train the Trainer Workshop on e-Authentication", and to enable bold models initiated by developing economies to drive e-authentication proliferation at scale.

Methodology

The project implementation

The participants at "Train the Trainer Workshop on e-Authentication" will be able to develop the lecturer materials and training courses for his/her economy based on the guideline of the trainer's manual.

- Review and improve the project periodically. A satisfaction and feedback survey will be assessed by participants for evaluation appraisal of the workshop.
