1. <u>Relevance – Benefits to region:</u> What problem does the project seek to address? What is the relevance of the project? Does it have sustained benefits to more than one economy?

Good progress is being made to reduce tariffs across the APEC region. As tariffs come down, however, the effects of NTMs on market access are more pronounced. Furthermore, the Bogor Goals Progress Report has identified that the use of NTMs in APEC are increasing (as they are globally). At CTI3 in 2014, New Zealand led a discussion on non-tariff measures that resulted in CTI's agreement that it needed to intensify discussions on addressing trade-restrictive NTMs.

Import licences appear to be one of the few non-tariff measures that have not previously been addressed by the CTI, despite being in place in a number of APEC economies. Import licensing can be defined as administrative procedures requiring the submission of an application or other documentation (other than those required for customs purposes) to the relevant administrative body as a prior condition for importation of goods. They may be put in place to pursue a variety of economic and non-economic aims, but may operate as a barrier to trade if their administration is not simple, transparent and predictable. The operations SMEs may particularly be affected by import licencing regimes due to administrative/historical bias (i.e. if the grant of a licence places an importer in a favoured position in subsequent years), the prospect of uncertainty or delay in issuing import licences, and the administrative burden of applying for import licences. Good regulatory practice suggests that regulations should be reviewed systematically to ensure they continue to meet their intended objectives efficiently and effectively, but once in place, there is a risk that import licensing regimes can be perpetuated without reconsideration of their costs and benefits.

Under the ambit of Non-Agriculture Market Access (NAMA)'s NTMs negotiations at the WTO and under some of the recent FTAs/RTAs, some countries are also pushing for export licensing notifications. Apart from focussing on existing import licensing obligations, export licensing is an unexplored topic that has the potential to become a barrier to trade if abused.

The aim of this project is to hold a workshop where import license regulators and administrators are able to:

- Consider economic and policy rationales for, and policy alternatives to, import licensing regimes;
- Learn about the WTO and FTA/RTA rules applicable to automatic and non-automatic import licensing regimes, as well as export licensing regimes;
- Discuss best practice for design and administration of import licensing regimes; and
- Develop recommendations for reducing the impact of import licenses on trade.

The workshop aims to contribute to economies' achievements of the Bogor Goals by fulfilling the collective Commitment in the Osaka Action Agenda to pursue a series of seminars/policy discussions on non-tariff measures (NTMs). The workshop will also contribute to APEC's ongoing work on good regulatory practice and the APEC priority for 2015 of fostering SMEs' participation in the regional and global economy.

The project is consistent with the Committee on Trade and Investment's continued focus on advancing regional economic integration through achievement of the Bogor Goals and trade facilitation. fulfilling the agreement in the APEC Strategic Blueprint for Promoting Global Value Chains Development and Cooperation to address trade issues that impact global value chains.

The workshop will provide sponsored travel opportunities to one or two participants per travel-eligible economy pursuant to APEC guidelines.
