UNIDROIT

- **Institute for the Unification of Private Law (UNIDROIT)**
- **Membership in all continents (63 member States)**
 - (10 APEC member States: Australia, Canada, Chile, China, Indonesia, Japan, Korea, Mexico, Russia and the United States)
- **24 international instruments open to ratification/adoption by all United Nations countries, regardless of UNIDROIT membership status**
- **Limited specific technical assistance and capacity building for UNIDROIT member States**

- **Capacity building and technical assistance done in collaboration with partner organisations**
 - Domestic and international aid organisations (USAid)
 - Cape Town Convention: Aviation Working Group
 - Contract Farming: FAO, IFAD
 - Protection of Cultural Property: UNESCO
