Hamza Haidon is manager of the Trade Policy Engagement Unit at the New Zealand Ministry for Foreign Affairs and Trade. Previously, he served as Deputy Permanent Representative to the World Trade Organization (WTO) in Geneva, leading negotiations for New Zealand (NZ) on WTO Reform, fisheries subsidies, and other key areas, and as New Zealand's APEC Inclusion Lead during NZ's host year and Chief Negotiator on the Indigenous Peoples Economic and Trade Cooperation Arrangement. He has also served as Acting Head of Mission at the NZ Embassy in Baghdad and served as a negotiator on a number of New Zealand's Free Trade Agreements.

Cher How represents Singapore for the Committee for Trade and Investment (CTI) at APEC. He is currently serving as the Deputy Director for the Multilateral Trade Policy Division at the Ministry of Trade and Industry. In his current role, he leads a team in overseeing the portfolio of APEC, G20 and WTO. Prior to his current appointment, he was the Deputy Director for the Southeast Asia and Oceania Division, where he led a team in furthering Singapore's bilateral economic, trade and investment interests in the Southeast Asia and Oceania region. He was Singapore's lead negotiator for the Chapter on Small & Medium Enterprises as well as the Chapter on Economic and Technical Cooperation for the Regional Comprehensive Economic Partnership Agreement. He was also Singapore's lead negotiator for the Association of Southeast Asian Nations (ASEAN) E-Commerce Agreement.

Ann Katsiak is Vice President of Economic Engagement and Private Sector Development at Nathan Associates. An expert on regional integration trade and trade facilitation, she also works on issues related to women's economic empowerment and strategic communications. As Chief of Party for the US-Support for Economic Growth in Asia (US-SEGA) project, she works closely with a range of government and private sector partners to develop policy programs supporting regional trade and investment issues across APEC's 21 member economies. US-SEGA also designs and delivers economy-level technical assistance and training across the region. Her previous work at Nathan supported Association of Southeast Asian Nations (ASEAN) integration and establishment of the ASEAN Single Window. Before that, she researched and coordinated the development of four trade facilitation tools and served as counterpart to the World Customs Organization on trade facilitation initiatives worldwide.

Leah Liston is the Director for Customs & Trade Affairs for the Office of the U.S. Trade Representative (USTR). She helps to coordinate trade policy relating to customs issues around





the U.S. government. Prior to joining USTR, she was an attorney at the Department of Commerce for twelve years, working with the International Trade Administration. She provided legal guidance on international trade law affecting trade in goods, in particular trade facilitation, technical barriers to trade and intellectual property rights. In that capacity, she was part of the U.S. delegation negotiating the Trade Facilitation Agreement at the WTO. She has a law degree from Georgetown Law School and a B.A. in economics from the Massachusetts Institute for Technology.

Josué C. Velázquez Martínez is a Research Scientist, and Lecturer at the Massachusetts Institute of Technology (MIT) Center for Transportation and Logistics specialized in Logistics and Supply Chain Management in transportation, manufacturing, and retail industries, and has more than 10 years of experience in conducting applied research on logistics sustainability and small firms in emerging markets. He joined MIT in 2016 and has served in multiple roles, including the Executive Director of the Supply Chain Management master's program, and Director of the MIT Supply Chain and Global Logistics Excellence for Latin America. He currently serves as the Director of the MIT Sustainable Supply Chain Lab, a research group focused on collaborating with organizations to improve their supply chain and logistics operations by considering environmental, social and business goals. He is also the Director of MIT Low Income Firms Transformation (LIFT) lab, a new research initiative aimed at alleviating poverty in Latin America and lifting the life of the bottom billion. He holds a Bachelor of Science in Industrial and Systems Engineering, a Master of Science in manufacturing systems, and a PhD in Industrial Engineering, all from Monterrey Tech, Mexico.

Devandran Muniandy is the GoTrade Regional Coordinator – Asia Pacific at DHL. His role includes coordinating customs modernization projects and capacity building for local businesses to access global market. Prior to joining DHL, he worked as Senior Officer of Central Management Team at the ASEAN Secretariat. He has also worked in public sector as Project Manager for Cross Border Rail and Head of Land Freight Unit.

Hannah Nguyen is a passionate champion for digitalization, and connecting disparate parts of, its ecosystem with over 14 years' experience in global trade and supply chain. Her role as Director of Digital Ecosystems at International Chamber of Commerce's Digital Standards Initiative (ICC DSI) is transforming the industry by uniting industry stakeholders, standards development organizations, solution providers, governments, and inter-government organizations in the common quest to promote policy coherence and harmonize digital trading standards for the benefit of businesses everywhere. He has a Bachelor of Arts in History from Hampden-Sydney College and a Master's in international relations from Johns Hopkins School of Advanced International Studies.
