



## Trends on NTMs

- Lower tariffs, but NTMs are increasing in number and complexity
- Technical measures, such as TBT and SPS are the most employed NTMs





## **TBT Agreement: Transparency**

### **TBT Agreement**

- Obligation of notification:
  - Technical regulations (Articles 2.9 and 2.11)
  - Conformity assessment procedures (Articles 5.6 and 5.8)

### WTO TBT Committee

- Decisions and recommendations
  - G/TBT/1/Rev.14
- TBT Triennial Review
  - G/TBT/46

# Identification of the problem

Final Review of APEC's Progress Towards the Bogor Goals (2020)

• TBT and SPS are by far **the most used** NTMs by APEC economies.

ABAC's Study on Non-Tariff Barriers in Agriculture and Food Trade in APEC (2016)

• TBT measures as the most challenging NTMs due to a perceived lack of transparency

Study of APEC Economies' TBT and SPS Specific Trade Concerns(2020):

- The predominant type of STC expressed by Members concerned the **lack of transparency** related to technical measures.
- Members raising or supporting a transparency-related STC often requested more detailed information regarding the scope of the measure, its technical requirements, and related timelines.
- In 77.00% of cases where an APEC economy was subject to a TBT STC, the WTO member that raised or supported the STC was another APEC economy.

## Identification of the problem

Lack of information and transparency is a disadvantage to businesses across the APEC region MSMEs find a lack of transparency and **poor dissemination of information** about the requirements and how to comply with these.

TBT measures are the **most burdensomeness** in comparison with other NTMs since they have the greatest negative impact in terms of time and cost


**Obligation to notify** according to WTO TBT Agreement

### Peru's initiative

**2020:** CTI approved Peru's Initiative that included a self-funded study and a PPD **2021:** self-funded study was carried out with the support of Peruvian academia sector and APEC private sector June 2022: Peru's Study on Transparency of Technical Barriers to Trade Notifications in the APEC Region was published

August 2022: PPD on Promoting Transparency of TBT WTO Notifications September 2022: Best Practices on Transparency of TBT Notifications

### Peru's initiative



Evaluate a randomly selected representative sample of TBT notifications by APEC economies between 2015 and 2019 Discuss the findings of the study and collect contributions from other stakeholders, including private sector and academia.

- Complement WTO guidelines on TBT Notifications.
- Explore capacity building opportunities

# Study

### **Objectives**

- To identify **key items** from TBT notifications that should be clearly written to improve the completeness and clearness of the information.
- To identify private sector perceptions on WTO TBT notifications and main challenges related to completeness and clearness of the information.

#### Results

- Regular notifications: **acceptable level of compatibility** by APEC Economies with WTO recommendations.
- APEC economies can improve upon their responses to specific items when completing their TBT notifications, in accordance with WTO's TBT Guidelines on Transparency
- Private sector experiences support these findings.
