

-Opportunity to influence regulations of trading partners, WTO members and domestic regulation.






# Article 2 TBT

- 2.9.2. notify other Members through the Secretariat of the products to be covered by the proposed technical regulation, together with a brief indication of its objective and rationale. Such notifications shall take place at an early appropriate stage, when amendments can still be introduced and comments taken into account;
- 2.9.4. without discrimination, allow reasonable time for other Members to make comments by writing, discuss these comments upon request, and take these written comments and the results of these discussions into account.



Notification Authority / TBT National Enquiry Point (Art.10.)



SUBREI-Regulatory Affairs Division.

Main Functions: facilitating access to information and implementation of TBT Agreement.

#### ACTIVE

• Notification to the TBT Committee the draft technical regulation and conformity assessment procedures to be elaborated by the Chilean regulatory agencies or Ministries.

• Addressing enquiries and comments received by others WTO members.

#### **PASIVE:**

- Distribution of the TBT Notification elaborated by WTO Members. Encourage the use of ePing. Export Alert!
- Addressing Chilean comments to TBT measures notified by WTO Members.



# 1. Transparency in Chile



Domestic coordination is of vital importance to notification procedures. Internal meeting with the Ministries before the TBT Committee to coordinate notification matters, among others.

# When / How to Notify?

- At an early stage when modifications are still possible "Draft Text".
- The new/modification regulation has a significant effect on trade.
- Notifications should be sent by WTO TBT ePing System, it could take only two days to process and circulated.
- Chile has published 974 notifications between 1996 and August 12, 2022.
- In 2014, for the first time Chile notified a draft law to the WTO (Alcoholic Beverages)




# 3. Comments to domestic notifications, and foreign notifications

- Domestic coordination is key to improve the participation and the quality of comments.
- Keeping track of the activities of regulatory bodies.
- Received and processed by TBT Enquiry Point.
- Making observations to the regulations at an early stage and making the necessary adjustments in case they are well considered.
- Helping to have clear, predictable and known standards and regulations.

- Increase capacity building activities to the regulatory bodies, training workshop for stakeholders.
- Technical assistance: Guide on how to notify and prepare comments.
- Private sector engagement.
- Having a formal mechanism of RIA to assess the potential impacts of a new regulation, specially on consumers, industry and trade.
