


### Purpose

- Provide an overview of the e-Longroom initiative;
- Quick response to COVID-19 with low overhead:
  - Reduces face-to-face interaction in customs offices;
  - Protects our employees;
  - Responds to industry requests to protect their own workforce.
- Principles of a post-COVID Digital Customs Strategy:
  - Digital
  - ➤ Resilient
  - ➤ Simple
  - ➤ Agile
  - Reconfigurable

#### Benefits for CBSA and Our Clients

- More efficient, flexible, resilient process:
  - Clients can submit requests from anywhere;
  - CBSA staff can authorize requests from anywhere by applying an electronic stamp;
  - Goods move faster!
- Reduces face to face interaction in CBSA offices, thereby protecting our employees and the employees of our clients;
- Comprehensive audit trail with automated tracking of time of receipt, reject (if applicable), and return of documents;
- Cost savings on handling, transport, off-site storage and destruction of paper records.

#### Requirements to Implement

• Simple set up of 2 generic inboxes per port:

Cargo: <u>CBSA.Manifest-395-Manifeste.ASFC@cbsa-asfc.gc.ca</u> Release: <u>CBSA.Commercial-395.ASFC@cbsa-asfc.gc.ca</u>

• Purchase and installation for each workstation:

-scanner that can read a barcode off a screen - \$500 -second monitor - \$350 -PDF writer software licence - \$50

• Development of standard operating procedures.
